Summer VPK funding from the State of Florida will be made available to children who will be turning 5 by September 1, 2015, who have not participated in a VPK program during the school year.

Dates: Thursday, June 4, 2015 – Friday, July 31, 2015

Hours: 7:30 a.m. – 3:00 p.m.

There is a 2-step application process to enroll in our Summer VPK Program.

Step 1: Complete this application and sign the VPK Attendance Policy. Return both to apply for a space for your child in our summer VPK program. Enrollment is limited to 12 children.

Step 2: Complete the State of Florida VPK Child Eligibility and Enrollment Certificate from the Early Learning Coalition of Alachua County. Visit their website at <https://vpkcp.floridaeearlylearning.com/> to register online or go to the Early Learning Coalition of Alachua County's office at 4424 NW 13 Street between the hours of 8 a.m. and 4 p.m. with the required documentation to receive the actual Certificate of Eligibility. You must return one copy of this certificate, with your signature, to our school to complete your application.

Abiding Savior Lutheran Preschool's Voluntary Pre-Kindergarten Attendance Policy

VPK Program Dates: Thursday, June 4 – Friday, July 31, 2015
(The school will be closed on July 2nd and 3rd.)

1. Your child must arrive in the classroom no later than 7:30 A.M.
2. Your child must participate in VPK activities until 3:00 P.M.
3. You must sign your child in and out each day your child attends our program.
4. You must call the school by 7:30 A.M. if your child is going to be late or absent. (Tardiness counts towards attendance. Therefore, excessive tardiness will be grounds for dismissal from the VPK program.)
5. Parents must complete and sign the Parental Choice and Attendance Verification Form EACH month.
6. Children who do not meet attendance requirements will lose VPK funding. The child may be allowed to remain in the classroom, but will be required to pay full tuition.
